Cost of Living Grant Programme

At the beginning of September 2022, we increased our grant budget to support organisations facing an increase in costs or demand for their services due to the increase in the cost of living. We no longer have a separate fund for cost-of-living grants, as this has been incorporated into our regular organisational grants. In 2022-23 £189.874 was awarded through the cost-of-living programme.
